PRESENTATION OF AUDITED ANNUAL ACCOUNTS FOR THE FINANCIAL YEAR 2023-24

The SFC also took note of the submission of the Audited Annual Accounts for the Financial Year 2023-24, along with the Annual Report, to the Ministry for its placement on the Table of both Houses of Parliament.

SFC noted that Audit Department, Chandigarh in the Annual Audit for the year 2023-24 has highlighted corrective action in case of certain persistent irregularities which are included in SAR . Audit has observed following: -

- (i) No Internal Audit was carried out by the Institute for the year 2023-24.
- (ii) As per the AIIMS Regulation 2019, the Institute Body should meet at least thrice a year however only one meeting was held during the year 2023-24.
- (iii) Physical verification of Assets and Inventory is still pending for the year 2023-24.

SFC advised the Institute to appropriately address all the observations of Audit Department and to convene the meeting of the IB at the earliest.

The SFC considered and approved the proposal of the Institute for grant of stipend of Rs. 15,000/- per month to students pursuing a two year MSc Nursing course in AIIMS Bathinda in accordance with MoHFW order No. Z-28016/60/2017-SSH (EO-3104589), dated 19th May 2017.

SFC also approved the proposal of the Institute for grant of stipend of Rs. 13,150/-

per month for B.Sc. Nursing students during their six-month internship period, in accordance with MoHFW Order No. A.11013/07/2019-N dated 06.07.2022.

The Institute was advised to start the MSc Nursing Course expeditiously.

CREATION OF INFRASTRUCTURE FROM CSR SUPPORT.

SFC took note of the creation of following infrastructure under CSR in AIIMS Bathinda for patient care :

- (a) **ONGC**. The organisation has proposed construction of a 300 room Night Shelter, under its CSR initiative.
- (b) <u>Dwarka Das Mittal Charitable Trust</u>. A 40 room Shelter Home with allied facilities will be provided by the Trust. The construction of the same shall be done by the Trust under the supervision of the institute. The expected cost of the project is approx Rs 5 Cr.
- (C) In addition to the above ONGC (through HLL HITES) and HMEL, Noida have offered the following equipment through CSR initiative:-

The SFC considered the agenda with the direction that the layout and construction of the Night Shelter should be designed in a way that accommodates the future requirements of an Institute of National Importance (INI). There should be provision for adequate number of toilets and provision should also be made for Private rooms with attached toilets .The Design of the Vishwamitra Sadan being constructed by Power grid in AIIMS Bilaspur should be referred to . It was also

advised that the operation and maintenance of the night shelter should be entrusted for operation to Charitable Trusts, societies, or NGOs etc as per certain defined parameters on a no-profit, no-loss basis.

As regards provision of equipment under CSR for the Department of Bio Chemistry /Pathology etc the SFC advised that while taking such equipment under CSR the Institute should ensure that these are of good quality and open systems so that the consumables can be procured at competitive rates .

ESTABLISHMENT BIPLANE CATHETERIZATION LABORATORY (CATHLAB)

SFC considered the proposal of the Institute for procurement of Bi-Plane Catheterization Laboratory (CATHLAB) as a Turnkey Project for the Department of Cardiology at AIIMS Bathinda in view of increase in patients .The SFC observed that the estimated cost of Rs 14Cr was on the high side . It was noted that the IPC of the Ministry in 2023-24 has disapproved the procurement of 3T MRI @Rs 22.93 cr (with GST and 5 years warranty) as that was found to be significantly higher than the last purchase price .

While approving the procurement of Bi Plane Cath Lab , the Institute was advised to procure the same with due diligence as per GFR/GeM/ in accordance with laid down specifications after ascertaining and ensuring rate reasonability .

It was noted that at present AIIMS Bathinda already has one Cath Lab which was received as a DPR item from PSA (HLL HITES).

PROCUREMENT AND ESTABLISHMENT OF MRI MACHINE

SFC considered the proposal of the Institute for procurement of 3T MRI for Radio Diagnosis Department in AIIMS Bathinda in view of increased patient load . SFC observed that the estimated cost of Rs 25 cr was significantly on the high side . It was noted that the IPC of the Ministry in 2023-24 has disapproved the procurement of 3T MRI @Rs 22.93 cr (with GST and 5 years warranty) as that was found to be much higher than the last purchase price .

While approving the procurement of 3T MRI, the Institute was advised to procure the same with due diligence as per GFR/GeM/ in accordance with laid down

specifications after ascertaining and ensuring rate reasonability.

It was noted that at present AIIMS Bathinda already has one 3T MRI equipment, which was received as a DPR item from PSA (HLL HITES).

PROCUREMENT AND ESTABLISHMENT OF CT SCAN MACHINE

SFC considered the proposal of the Institute for procurement of 256 slice CT machine for Radio Diagnosis Department in AIIMS Bathinda in view of increased patient load . SFC observed that the estimated cost of Rs 25 cr was significantly on the high side . It was noted that the IPC of the Ministry in 2023-24 has disapproved the procurement of 256 slice CT @Rs 15.60 cr (with GST and 5 years warranty) as that was found to be much higher than the last purchase price

While approving the procurement of 256 slice CT machine the Institute was advised to procure the same with due diligence as per GFR/GeM/ in accordance with laid down specifications after ascertaining and ensuring rate reasonability.

It was noted that at present AIIMS Bathinda already has one 256 slice CT machine which was received as a DPR item from PSA (HLL HITES).
