

- Should have bilateral frame to provide exceptional costal margin retraction.
- Should have various detachable blade options in different configurations for retraction of abdominal wall, solid / hollo. Blades like Balfour, Richardson, Malleable, Harrington, Deaver, Kelly etc. along with Pediatric blades.
- All blades should be detachable from blade holder & simultaneously different blade should be interchangeable to any/ all blade holders.
- Blade holder should have inbuilt angling system on the blade holder.
- Blade & blade holder should have fixed retraction feature to hold organ
- Blade holder rods should have ratchet mechanism in built for retraction.
- Should be of high-quality steel & US FDA approved.
- Physical demonstration must, as per user recommendation.
- 5 years warranty.
