1. Maximum age limit for applying for the aforesaid posts on deputation is 56 years as on last date of receipt of applications.
2. This is a ‘rolling advertisement’ and will be used to fill the unfilled-posts by issuing subsequent notifications on the website- www.aiimsbathinda.edu.in for at least one-year till the Notice of closure, without the need to re-publish on the web-site. Hence, candidates may keep looking for employment opportunity vide subsequent notification on the website. This will be applicable only if the posts remain unfulfilled and competent authority decides to publish vacancy notification, at his sole discretion.
3. **Candidates who have applied earlier and were declared Eligible/ Provisionally Eligible for the above-mentioned posts vide Advertisement No. AIIMS/BTI/Rect.Cell/DeputationPosts/214 dated 19 Mar 2021 and Advertisement No. AIIMS/BTI/Rect.Cell/DeputationPosts/215 dated 24 Mar 2021 need not apply again.**
4. The period of deputation will be for a period of 3 (three) years and extendable for maximum period of seven years as per DoPT guidelines O.M.No.6/8/2009-Estt.(Pay II) dated 17.06.2010, as amended from time to time.
5. The last date of receipt of complete application on the prescribed proforma along with required **documents through proper channel is 30 days after publication of this advertisement in the Employment News.**
6. Application format have been uploaded on the AIIMS, Bathinda website www.aiimsbathinda.edu.in. Application format can be downloaded from the website. The Officers/Officials who fulfill the specified eligibility conditions may submit their application in the prescribed proforma at **Annexure-I** through proper channel along with attested copies of all relevant certificates to be sent to “**The Deputy Director, All India Institute of Medical Sciences, Mandi Dabwali Road, Bathinda-Punjab - 151001**” superscribing the envelope “Application for the post of AIIMS Bathinda” by Speed Post/Registered Post only. Application received through any other medium will not be accepted and **if delay is expected in getting endorsement of the employer concerned on the original application, the applicants may submit an advance copy of the application along with all enclosures directly.**

7. For those who do not follow Central Government Pay Scales, the comparative chart regarding the pay scale granted to the Official with Central Government pay scale, duly certified by their Head of Office, should be submitted for scrutiny.

8. The qualification/eligibility prescribed is minimum requirement and the some does not automatically make candidate eligible for selection. Based on bio-data, the candidates will be shortlisted and only shortlisted candidates will be called for interview. Application of eligible officers who can be spared in the event of the selection may be forwarded through proper channel to the undersigned at the address given above within 30 days of publication of this advertisement in the employment News along with

- (a) Attested copies of the up-to-date APARs for last five (05) years;
- (b) Vigilance Clearance Certificate clearly indicating that no disciplinary or criminal proceedings are either pending or contemplated against the officer concerned;
- (c) Statement showing the minor/major penalties imposed, if any, and
- (d) Integrity Certificate
- (e) NOC
