**2. ESSENTIAL QUALIFICATIONS:**

SENIOR RESIDENTS: -

- A medical qualification included in the first or second schedule or Part II of the third schedule to the Indian Medical Council Act 1956 (persons possessing qualifications included in the Part II of the third schedule should also fulfil the conditions specified in Section 13 (3) of the Act).
- Must be registered with the Central/State Medical Council.
- A postgraduate degree i.e., MD/MS in the specialty concerned or its equivalent from a recognized University / Institute.

3. The above vacancies are provisional and subject to variation. The Director, AIIMS, Bathinda reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India rules/circulars and requirements.

4. Reservation will be as per Government of India Policy.

5. Upper Age Limit as on 08 Sep 2021

(a) For eligibility to apply for these posts upper age limit as on **08 Sep 2021** will be **45 years**. This is **relaxable** for **SC/ST** candidate for a maximum period of **five years**. In the case of **OBC** candidates it is relaxable upto a maximum period of **three years**. In the case of Persons with Benchmark Disabilities (**PwBD**) candidates, this is relaxable upto maximum period of **Ten years for General Category, Thirteen years** for **OBC** category and **Fifteen** years for SC/ST category candidates.

(b) **To be eligible for selection** for these posts, the candidate should pass the qualifying examination by 08 Sep 2021 & result should be declared to this effect on or before this date.

(c) The candidates who are in service in any Government Institutions are required to submit No Objection Certificate from the employer at the time of Interview.

6. **Application Fee: General category: ₹ 1,000/- and for PwBD Candidate: NIL**

7. The fee shall be paid in the form of a **Demand Draft in favor of " EXECUTIVE DIRECTOR AIIMS BATHINDA (HR)"** payable at Bathinda. Name of applicant along with telephone number, post applied for should be written on the back side of demand draft. This fee once remitted will not be refunded under any circumstances or adjusted.

8. **PAY SCALE**

Senior Resident: (Level – 11 of the Matrix (Pre-Revised PB – 3, entry pay of the ₹ 67,700/- Per Month + NPA + usual allowances admissible under rules) **NPA is applicable for only Medical Candidates.**

9. Reservation for Persons with Benchmark Disabilities Candidates (PwBD) is applicable by Govt. of India Policy, which will be provided on horizontal basis to PwBD candidate in their respective categories.

10. Criteria for Persons with Disabilities Candidates:

i. The disability certificate should be issued by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals / Institutions and countersigned by Medical Superintendent / CMO / Head of Hospital / Institution.

11. **SELECTION PROCEDURE:** The selection will be on the basis of the interview. The list of selected candidates will be uploaded on website. Candidates are advised to check the Institute website regularly for information.

12. **DOCUMENTS TO BE PRODUCED IN ORIGINAL AT THE TIME OF INTERVIEW:** The Candidate should bring following original documents and two set of self-attested photocopies at the time of interview with application form: -

- (a) Identity Proof (PAN Card, Passport, Driving License, Voter Card, Aadhar Card etc.)
- (b) Address Proof.
- (c) Certificate showing Date of Birth. (Passport/Birth Certificate/Driving License). No Age relaxation would be available to SC/ST/OBC candidates applying for unreserved vacancies.
- (d) Four recent passport size photographs.
- (e) Photocopies of PAN Card and Bank Passbook (At the time of Joining for only selected candidates).
- (f) Class 10<sup>th</sup> & 12<sup>th</sup> Marksheet and Certificates.
- (g) Qualifying degree-
- (h) MBBS Marksheet and degree certificates.
- (i) MD/DNB/MS degree certificate.
- (j) DM/M.Ch/DNB degree certificates.
- (k) Attempt and Internship Certificate.
- (l) Registration with Medical Council of India/State Medical Council.
- (m) Experience Certificate.
- (n) FMGE certificate conducted by NBE (For foreign graduate).
- (o) Candidates working in Government Institution- No Objection Certificate.
- (p) Publications.

### **TERMS & CONDITIONS**

- (a) **Tenure**: - The appointment is for a period of 06 months. This appointment will not vest any right to claim by the candidate for permanent absorption in the institute OR for continued contractual appointment, which may be renewed or terminated as decided by the Institute.
- (b) **Remuneration**: - The appointment will entitle the appointee to a remuneration as per pay-scale.
- (c) **Leave**: - The leave entitlement of the appointee shall be governed by the Institute's leave rules as amended from time to time.
- (d) The Competent Authority reserves the right to change the number of vacancies, withdraw the process in full or in part and also the right to reject any or all applications received without assigning any reasons or giving notice etc.
- (e) The prescribed qualification is minimum requirement and mere possessing the same does not entitle any candidate for selection.
- (f) This appointment is full time and private practice of any kind is prohibited. He/ She will have to work in shifts and can be posted at any place in the Institute.
- (g) He/ She should also note that he/she will have to conform to the rules of discipline and conduct as applicable to the Institute employees.
- (h) No travelling or other allowances will be paid to the candidate for joining the post. The candidate should not have been convicted by any Court of Law. Canvassing in any form will render the candidate disqualified for the post.
- (i) If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have willfully suppressed any material information, he / she will be liable to be removed from services and such action as the appointing authority may deem fit.
- (j) The decision of the Competent Authority regarding selection of the candidate will be final and no representations will be entertained in this regard. The decision of the committee shall be final and binding.
- (k) All disputes will be subject to jurisdiction of Court of Law at Bathinda.
