7. For those who do not follow Central Government Pay Scales, the comparative chart regarding the pay scale granted to the Official with Central Government pay scale, duly certified by their Head of Office, should be submitted for scrutiny.

8. The qualification/eligibility prescribed is minimum requirement and the some does not automatically make candidate eligible for selection. Based on bio-data, the candidates will be shortlisted and only shortlisted candidates will be called for interview. Application of eligible officers who can be spared in the event of the selection may be forwarded through proper channel to the undersigned at the address given above within 30 days of publication of this advertisement in the employment News along with

- (b) Vigilance Clearance Certificate clearly indicating that no disciplinary or criminal proceedings are either pending or contemplated against the officer concerned;
