1. ESSENTIAL QUALIFICATIONS:

SENIOR RESIDENTS: -

- (a) A medical qualification included in the first or second schedule or Part II of the third schedule to the Indian Medical Council Act 1956 (persons possessing qualifications included in the Part II of the third schedule should also fulfil the conditions specified in Section 13 (3) of the Act).
- (b) Must be registered with the Central/State Medical Council.
- (c) A postgraduate degree i.e., MD/MS/DNB as per MCI rule in the specialty concerned from a recognized University / Institute.

2. Process to apply:-

Important Instructions :-

- Separate form to be filled and fees to be paid if applying for more than one post/ department
- All original documents to be brought on the date of interview as mentioned in para 16 below.
- 6. The above vacancies are provisional and subject to variation. The Director, AIIMS, Bathinda reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India rules/circulars and requirements.
- 7. Reservation will be as per Government of India Policy.
- 8. Maximum Age-limit :-

Senior Resident: - Not exceeding 45 (Forty-Five) years as on 25 Sep 2023.

- (a) Upper age limit shall be determined as on the date of publishing this notification in institute website.
- (b) No age relaxation would be available to SC/ST/OBC Candidates applying for unreserved vacancies.

(c) Age relaxation permissible to various categories is as under: -

SC/ST Candidates	05 years
OBC Candidates	03 years
For Persons with Disabilities	10 years

Age relaxation will be regulated as per the DoPT instructions.

- (d) To be eligible for selection for these posts, the candidate should pass the qualifying examination by 25 Sep 2023 and result should be declared to this effect on or before this date.
- (e) The candidates who are in service in any Government Institutions are required to submitNo Objection Certificate from the employer at the time of Interview.
- (f) Candidates applying under any of the reserved category posts, viz. SC/ST/OBC/OH will be considered subject to Caste/OH Certificate issued by the appropriate/ Competent Authority on the prescribed format. Community should be clearly and legibly mentioned in the Certificate. OBC candidate's eligibility will be based on the caste(s) borne in the Central List of Government of India. OBC candidate(s) should not belongsto Creamy Layer and their sub-caste should be match with the entries in Central List of OBC, failing which their candidatures will not be considered under any of the applied reserved category post(s).
- (g) Only such persons would be eligible for reservation under OH quota in service/ posts who suffer from not less than 40% of physical disability. Person who wants to avail the benefit of reservation would have to submit a Disability Certificate as issued by a Competent Authority in prescribed format. The candidates are to satisfy all eligibility criteria. They must possess the educational qualification and experiences as recognized by the Govt. of India. Their candidature will be cancelled at any stage if it is found that their educational qualification or experiences is not recognized by the Govt. of India.

11. PAY SCALE

Senior Resident: (Level – 11 of the Matrix (Pre-Revised PB – 3, entry pay of the ₹ 67,700/- Per Month + NPA + usual allowances admissible under rules) NPA is applicable for Medical Candidates only.

- 12. Reservation for Persons with Benchmark Disabilities Candidates (PwBD) is applicable by Govt. of India Policy, which will be provided on horizontal basis to PwBD candidate in their respective categories.
- 13. Criteria for Persons with Disabilities Candidates:

The disability certificate should be issued by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals / Institutions and countersigned by Medical Superintendent /CMO / Head of Hospital / Institution.

- 14. SELECTION PROCEDURE: Based on bio-data, the Search cum Selection Committee may short-list Candidates for interview or they may be asked to appear in a written examination in case of large number of applicants. Candidates called for interview will have to produce all relevant original documents in proof of details furnished in their application at the time of interview.
- 15. Selection will be made on the basis of Interview/written. Short-listing a candidates for interview/written will be done on the basis of educational qualification, experience etc. and /or as per the short-listing criteria as may be decided by the Competent Authority. In case large number of application are received for the Senior Resident post, a Screening Test may be conducted for short-listing of candidates for which the Syllabus, Scheme and the method of Screening Test (Computer Based Test or Offline Test) shall be notified in due course on the website of AIIMS, Bathinda. The decision of Director, AIIMS, Bathinda in this regard be final and binding.
- 16. <u>DOCUMENTS TO BE PRODUCED IN ORIGINAL AT THE TIME OF INTERVIEW:</u> On the day of walk-in-Interview, the candidate is required to be present 'in person' with filled application form (including application fee i.e., Copy of Transaction receipt) and all original certificates in Recruitment Cell, Ground Floor, Admin Block, Medical College Building, AlIMS Bathinda before 09:00 AM along with one set of self-attested photocopies at the time of Interview:
 - (a) Identity Proof (PAN Card, Passport, Driving License, Voter Card, Aadhar Cardetc.)
 - (b) Address Proof.
 - (c) Certificate showing Date of Birth. (Passport/Birth Certificate/Driving License). No Age relaxation would be available to SC/ST/OBC candidates applying for unreservedvacancies.
 - (d) Four recent passport size photographs.
 - (e) Photocopies of PAN Card and Bank Passbook (At the time of Joining for onlyselected candidates).
 - (f) Class 10th & 12th Marksheet and Certificates.
 - (g) Qualifying degree-
 - (h) MBBS Marksheet and degree certificates.
 - (i) MD/DNB/MS degree certificate.
 - (j) DM/M.Ch/DNB degree certificates.
 - (k) Attempt and Internship Certificate.

- (I) Registration with Medical Council of India/State Medical Council.
- (m) Experience Certificate.
- (n) FMGE certificate conducted by NBE (For foreign graduate).
- (o) Candidates working in Government Institution- No Objection Certificate.
- (p) Publications.

<u>Note:</u> Candidates who do not produce the above-mentioned original documents at the timeof interview will not be considered for selection.

TERMS & CONDITIONS

- 1. **Tenure.** The appointment is for a period of 01 Year and extendable to 03 Years (Maximum) upon the recommendation of the Head of the Department/discretion of the competent authority. This appointment will not vest any right to claim by the candidate for permanent absorption in the institute or for continued appointment, which may be renewed or terminated as decided by the Institute.
- 2. <u>Remuneration.</u> The appointment will entitle the appointee to a remuneration as per payscale.
- 3. <u>Leave.</u> The leave entitlement of the appointee shall be governed by the Institute's leave rulesas amended from time to time.
- 4. The post of Senior Resident will be regulated as per the provision of Central Residency Schemeand governed by CCS (Temporary Service) Rules.
- 5. If an appointee wishes to apply somewhere else or resign within the first 03 (Three) months of joining, then neither he/she will be issued a No Objection Certificate (NOC) nor he/she will receive any Relieving Letter or Experience Certificate.
- 6. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc, or any other benefits available to the Government Servants, appointed on regular basis,
- 7. The decision of the competent authority regarding selection of candidates will be final and no representation will be entertained in this regard.
- 8. In case, any information given or declaration by the candidate is found to be false or if the candidate has wilfully suppressed any material information relevant to his/her appointment, he/she will be liable to be removed from the service and any action taken as deemed fit by the appointing authority.
- 9. The candidates are advised to see the institutional web site for any additional information and confirm about date and time / venue before coming. No personal / by post information will be sent.
- 10. The Competent Authority reserves the right to change the number of vacancies, withdraw the process in full or in part and also the right to reject any or all applications received without assigningany reasons or giving notice etc.
- 11. The period of experience wherever prescribed shall be counted after obtaining the prescribed qualification.
- 12. The prescribed qualification is minimum requirement and mere possessing the same does notentitle any candidate for selection.

- 13. This appointment is full time and private practice of any kind is prohibited. He/ She will have towork in shifts and can be posted at any place in the Institute.
- 14. He/ She should also note that he/she will have to conform to the rules of discipline and conductas applicable to the Institute employees.
- 15. No travelling or other allowances will be paid to the candidate for joining the post. The candidate should not have been convicted by any Court of Law. Canvassing in any form will render the candidate disqualified for the post.
- 16. If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have will fully suppressed any material information, he / she will be liable tobe removed from services and such action as the appointing authority may deem fit.
- 17. The candidate submitted the certificate at the time of interview, mentioned his/her tenure will be completed on or before **25 Sep 2023.**
- 18. The decision of the Competent Authority regarding selection of the candidate will be final and no representations will be entertained in this regard. The decision of the committee shall be final and binding.
- 19. All disputes will be subject to jurisdiction of Court of Law at Bathinda.
