**All India Institute of Medical Sciences, Bathinda** is a premier Institute of National Importance established by the Ministry of Health & Family Welfare, Government of India under the Pradhan Mantri Swasthya Suraksha Yojana (PMSSY) with the aim of correcting regional imbalance in quality tertiary level healthcare in the country and attaining self-sufficiency in graduate, postgraduate and higher medical education and training.

- I. The above vacancies are provisional and subject to variation. The Executive Director, AIIMS, Bathinda reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India Rules/Circulars and requirements or otherwise.
- II. Reservation will be as per Government of India Policy.
- III. The cut-off date to determine the maximum age limit, essential qualification & experiences will

be the last date of submission of offline application.

IV. The period of experience wherever prescribed shall be counted after obtaining the prescribed qualification.

#### B) Application Fees:

- b. There is no fee for **SC/ST/PwBD/Ex-Servicemen** Category candidates.
- c. Application fee once remitted shall not be refunded under any circumstances.
- d. Applications without the prescribed fee would not be considered and summarily rejected.

## C) Application Process:-

**a)** Aspiring applicants who meet all the eligibility criteria for the above said post may **submit a hard copy of their application in offline mode, either by post or by hand, after filling out the Google Form available at the link given below**. The Google Form must be filled out on or before 27 January 2026 by 05:00 PM IST.

b) The last date of offline submission of applications will be 03 February 2026. In case the last date falls on weekly off or holidays, then the last date of submission of application

will be shifted to the next working day (up to 05.00 PM IST). The hard copy of the offline applications has to be sent along with self-attested copies of certificates/documents in support of fulfilling the essential criteria of age, educational qualification, experiences etc. besides others in support of their candidature within the last date of receipt of offline application. The hard copy of application form shall be enclosed with self- attested copies of Matriculation Certificate, Degree Certificate/Mark-Sheets or equivalent certificates/mark sheets, Experiences Certificates indicating teaching institutions etc. The Experience Certificate should clearly show the period of experience, duration of experience ("from" to "to"), Nature of experience etc. The candidates can only mention those experiences which are recognized. The signed hard copy of offline application along with all above-mentioned certificates/documents should be sent through Speed Post/Registered post/by hand within stipulated period.

- d) Candidates are advised to fill their correct and active-mail ID in the offline application, as all correspondences will be made by the Institute through e-mail. Test/ Interview schedule will be mailed in due course to the candidate in their registered e-mail.
- e) The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling eligibility criteria as on the closing date of offline applications failing which their application will be rejected.

# D) Maximum Age Limit :- 50 Years

- a) Maximum age will be calculated as on the last date of the receipt of the offline application i.e., **03 February 2026.**
- b) Upper age limit shall be determined as on last date of submission of offline applications.
- c) No age relaxation would be available to SC/ST/OBC candidates applying for unreserved vacancies.

e) Age relaxation to other categories of the candidates will also be applicable as per the DoPT instructions. However, age relaxation will be regulated as per the DoPT instructions.

## E) Reservation Criteria:-

#### (a) For PwBD Candidates:

Reservation to candidates belonging to Person with Benchmark Disability (PwBD) category is applicable by Govt. of India Policy, which will be provided on Horizontal basis to PwBD candidates in their respective categories.

#### Criteria for Person with Benchmark Disability Candidate:

The disability certificate should be issued by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals / Institutions and countersigned by Medical Superintendent /CMO / Head of Hospital / Institution. Reservation for PwBD will be as per the guidelines /Instruction contained in DoP&T OM No. 36035/02/2017-Estt (Res) dated 15.01.2018 with regard to reservation for persons with disabilities. Only such persons would be eligible for reservation under PwBD quota in service/posts who suffer from not less than 40% of physical disability. Person who wants to avail the benefit of reservation would have to submit a Disability Certificate as issued by a Competent Authority in prescribed format. However, the candidature of PwBD applicant is subject to evaluation by a Medical Board duly constituted by the Executive Director of respective AIIMS or by the respective institute. This Medical Board will evaluate suitability of candidates for the post he/she is being considered for. All the instructions of Govt. of India as amended and as applicable in this matter will be followed.

#### (b) For OBC Candidate:-

Candidates applying under OBC category must produce the valid caste certificate in the format provided by the DoP&T vide O.M. No. 36036/2/2013-Estt. (Res.) dated 30.05.2014 and further clarification issued by DoP&T OM No. 36036/2/2013 Estt(Res-I) dated 31.03.2016. The certificate must mention the non- creamy layer status of the applicant (Non-creamy layer status issued by an authority mentioned in DOPT Office Memorandum no. 36012/22/93- Estt. (SCT) dated 15.11.1993). The OBC applicants who belong to the "Non-Creamy Layer" and whose caste appears in the Central List of the OBCs (notified by the Ministry of Social Justice and Empowerment on the recommendations of the National Commission for Backward Classes available at the website http://ncbc.nic.in, shall be eligible to be considered under the OBC category (Validity period of OBC Certificate in respect of non-creamy layer status of the applicants as per DOPT Office Memorandum No. 36036/2/2013-Estt. (Res-I) dated 31 March 2016). The validity of the non-creamy layer certificate shall be issued for the financial year 2025 2026 (which is the year of advertisement) (considering income up to financial year ending on 31st Mar, 2025), issued from 1st April 2025 to 03 February 2026. If the applicant does not have the OBC non-creamy layer certificate valid for the financial year 2025-2026 at the time of applying, the applicant must submit the previously issued (older) OBC non- creamy layer certificate or the acknowledgment slip of the OBC non creamy layer certificate application. However, at the time when asked to submit/upload the valid certificate, the applicant must produce the applicable certificate valid for financial year (2025- 26) as said above. This additional certificate (if any) must have a reference of his / her already issued original caste certificate.

#### (c) For EWS Candidate:-

The vacancies advertised under EWS Category are as per the instructions issued by DoPT, Ministry of Personnel, Public Grievances & Pension, Govt. of India, vide OM. No. 36039/1/2019-Estt (Res), dated 31.01.2019. Application under EWS category will be considered subject to submission of Income and Assets certificate on a prescribed format issued by the competent authority and subject to verification of genuineness of the certificate by the issuing authority. In pursuance to DoP&T OM No. 36039/1/2019-Estt (Res), dated 31.01.2019, a EWS certificate issued in prescribed format for employment in Central Government on the basis on income of financial year 2024-2025, issued from 1st April 2025 to 03 February 2026. If the applicant does not have the EWS Category certificate valid for the financial year 2025- 2026 at the time of applying, the applicant must upload the previously issued (older) EWS certificate or the acknowledgment slip of the EWS certificate application. However, at the time when asked to submit/upload the valid certificate, the applicant must produce the applicable certificate valid for financial year (2025- 26) as said above.

(d) Candidates who fail to produce valid category certificate OBC/EWS/SC/ST/PWBD etc. during document verification or as and when required to produce the same, the candidature will be cancelled. All candidates are advised to obtain required valid category certificate in advance to avoid cancellation of candidature at any stage of the recruitment process.

- (e) Candidates who have claimed the reservation category and failed to produce a valid category certificate as applicable as per published criteria the candidature shall be cancelled in the reserved category, and allocated seats shall be forfeited.
- (f) Candidates applying under any of the reserved category posts, viz. SC/ST/OBC/EWS/PwBD will be considered subject to Caste/PwBD Certificate issued by the appropriate/Competent Authority in the prescribed format. Community should be clearly and legibly mentioned in the Certificate.

#### **GENERAL CONDITIONS**

- 1. The post carry usual allowances as admissible to Central Government Employees of similar status stationed at AIIMS Bathinda, Punjab.
- 2. The candidates are to satisfy all eligibility criteria before offline application. They must possess the educational qualification and experiences as recognized by the Govt. of India. Their candidature will be cancelled at any stage if it is found that their educational qualification or experiences are not recognized by the Govt. of India.
- 3. **Experience:-** The experience will be counted as on last date of submission of offline application after obtaining the prescribed educational qualification.
- 4. In case there are a large number of applications, all the applicants may be called to sit in the recruitment exam and only such number of successful candidates (depending on the number of vacancies and as decided by the competent authority) will be called to participate further in the selection process.
- 5. **Site of Interview**: Interviews will be held at AIIMS Bathinda or any other place as decided by the Executive Director, AIIMS, Bathinda. No TA/DA will be paid for appearing in the Exam/ Interview.
- 6. **Document Verification**: The original certificates/documents of successful candidates will be verified for which dates will be notified after declaration of screening test result or before the interview. On the basis of screening test, if any, the provisionally qualified candidates will be required to produce following original certificates/ documents along with one set of photocopies, duly self-attested viz.:
  - i) Copy of Admit Card (if Written Examination held).
  - ii) Certificate showing Date of Birth. (10th Certificate/ Birth Certificate).
  - iii) Class 10th & 12th Marksheets and Certificates.
  - iv) All Originals documents in support of Essential Qualification for the above mentioned post.
  - v) Caste certificate if applied under SC/ST/OBC/EWS category issued by the competent authority.
  - vi) The Disability Certificate, if applied under Person with Benchmark Disability (PwBD) category.
  - vii) No Objection Certificate if in regular employment in Government/Semi Government/PSU Institution.
  - viii) Experience Certificate, if any (With Supporting evidence viz. PF/ESI/Account Statement/Salary slip along with experience certificate).
  - ix) Identity Proof (PAN Card, Passport, Driving License, Voter Card, Aadhaar Card and Government

- x) Address Proof (Aadhaar Card, Passport, Ration Card, Driving License and Government Approved Address Proof)
- xi) Any other relevant documents.
- 7. The applicants already in Government service shall have to produce **No Objection Certificate** from their present employer. The No Objection Certificate should clearly state that the candidate will be allowed to join if selected and not merely for appearing in the interview.
- 8. **AIIMS, Bathinda decision will be final**: The decision of the AIIMS, Bathinda in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, mode of selection, conduct of examination(s), allotment of examination centers if any, selection and allotment of posts to selected candidates will be final and binding on the candidates and no enquiry / correspondence will be entertained in this regard.
- 9. Any corrigendum or revision of the advertisement or any other information regarding this recruitment will be posted on the Official website of AIIMS, Bathinda only in due course. Candidates are advised to visit Institute website regularly for updated information in this regard.

#### **OTHER INFORMATION FOR THE CANDIDATES**

- 1. The Institute strives to have a workforce which reflects gender parity and women candidates are encouraged to apply.
- 2. **Probation period**: The period of probation is of two (2) years.
- 3. The applicants, who do not have requisite qualifications up to the last date for submission of offline applications, will not be considered and will be summarily rejected.
- 4. Incomplete application(s) and without requisite fee will be summarily rejected. Applications received after the last date of submission of offline application will not be considered.
- 5. The employees of the Institute will be governed by the New Pension Scheme as per the provision contained in the Ministry of Finance, Department of Economic Affairs (ECB & PR Division). Notification No. 5/7/2003-ECB&PR dated 22.12.2003.
