<b>Scheme of Examination</b>	<p>a) The examination will be of 100 MCQs Based Questions carrying total 100 marks of 90 minutes duration. Each question will carry 01 mark.</p> <p>b) There will be negative marking of 1/4 marks for each incorrect answer.</p> <p>(Top 05 candidates on the basis of written examination will be shortlisted in each Branch/Course (i.e. BAMS, BHMS, BNYS, BSMS, BUMS). The written examination is only screening examination and the marks obtained by candidates in written examination will <b>NOT</b> be added in Final Merit List.</p>
<b>Qualifying Marks</b>	The qualifying marks in written examination will be minimum 40 % of total marks of written examination for UR category and 35 % marks for SC, ST and OBC category in written Examination.
<b>Interview</b>	<p>Interview will be for 125 Marks.</p> <p>Top 05 candidates in each Course/Branch (i.e. BAMS, BHMS, BNYS, BSMS, BUMS) will be shortlisted for Interview. The date of Interview will be published in AIIMS Bathinda website in due course.</p> <p>The final merit list will be prepared based on the marks <b>obtained in Interview only.</b></p>
<b>Syllabus of Examination</b>	The syllabus will be in accordance with the education qualification as mentioned in the Eligibility Section of Advertisement. The question paper carrying total 100 questions of 100 marks will be provided to the candidate base on their Course/Branch (i.e. BAMS, BHMS, BNYS, BSMS, BUMS).
<b>Rules of Scribe and Compensatory Time</b>	<p>Eligibility for Scribe and/or compensatory time:</p> <p><b>I. The persons with Benchmark Disabilities (PwBD) defined under section 2(r) of the RPWD Act, 2016</b></p> <p>A. Persons with Benchmark Disabilities in the categories of blindness, locomotor disability (both arms affected – BA) and cerebral palsy will be provided with the facility of a scribe if desired by the person against self-undertaking as per Appendix A Part A-1.</p> <p>B. The PwBD candidates in the category of blindness, locomotor disability (both arms affected-BA) and cerebral palsy are allowed Compensatory Time of twenty minutes per hour of the examination if desired by the person against self-undertaking as per Appendix A Part A-1.</p> <p>C. In the case of other categories of Persons with Benchmark Disabilities as defined under</p>

	<p>section 2(r) of the RPWD Act, 2016, the facility of scribe / Compensatory time will be allowed to such applicants on the production of a certificate to the effect that the person concerned has physical limitation in to write, and scribe is essential to write the examination on his behalf from the Chief Medical Officer/ Civil Surgeon/ Medical Superintendent of a Government Health Care institution as per the prescribed proforma (Appendix A Both part A-1 and A-2).</p> <p><b>II. The persons with specified disabilities covered under the definition of section 2(s) of the RPWD Act, 2016 but not covered under the definition of section 2 (r) of the said Act, i.e. persons having less than 40% disability and having difficulty in writing.</b></p> <p><b>A. In the case of those with less than Benchmark disabilities as defined under section 2(r) of the RPWD Act, 2016, the facility of scribe and or / Compensatory time shall be granted solely to those having difficulty in writing subject to the production of a certificate to the effect that the person concerned has physical limitation to write and that scribe is essential to write examination on his/her behalf from the competent medical authority of a Government Health Care institution as per prescribed proforma. (Appendix A Both part A-1 and A-3).</b></p>
<b>Request for Scribe and Compensatory time</b>	<b>The eligible candidates who desire to get the benefits of scribe and Compensatory time must send the duly filled Annexures attached with to Examination Cell, AIIMS Bathinda through E-mail (examcellaiimsbti@gmail.com) on or before <u>10/07/2026</u>.</b>
<b>Resolution of Tie Cases</b>	<b>In cases where more than one candidate secures equal MARKS, tie will be resolved;</b> <b>(i) First, by using date of birth with older candidates placed higher;</b> <b>(ii) If not resolved by (i), the number of wrong answers / negative marks will be used, wherein those with fewer wrong answers / negative marks will be placed higher.</b>
