4. No age relaxation would be available to SC/ST/OBC candidates applying for unreserved vacancies.

5. Ex-servicemen/Commissioned Officers including ECO and SSCO seeking age relaxation shall be required to submit documents issued by the competent authority in support of their category.

(a) *Ex-servicemen who have already secured employment in civil side under Central Government on regular basis after availing of the benefits of reservation given to ex-servicemen for their reemployment are NOT eligible for claiming benefits of reservation under EXS category. However, they are eligible for age relaxation as per rules.*

(b) *For any serviceman of the three Armed Forces of the Union to be treated as Ex-Serviceman for the purpose of securing the benefits of reservation, he must have already acquired, at the time of submitting his/her application for the Post, the status of ex-serviceman and /or is in a position to establish his acquired entitlement by documentary evidence from the competent authority that he would complete specified term of engagement from the Armed Forces within the stipulated period of one year from the CLOSING DATE FOR RECEIPT OF APPLICATION or otherwise than by way of dismissal or discharge on account of misconduct or inefficiency.*

6. The candidates are to satisfy all eligibility criteria before offline application. They must possess the educational qualification and experiences as recognized by the MCI/NMC/Govt. of India. Their candidature will be cancelled at any stage, if, it is found that their educational qualification or experiences is not recognized by the Govt. of India.

7. PwBD candidates suffering from not less than 40% of specified disability and fulfilling the “functional requirements” of the posts shall be eligible for horizontal reservation of 4% as per the Govt. of India rules on production of valid disability certificate issued by the competent/appropriate authority.

Important Instructions for Candidates:

1. Age and all other qualifications will be counted as on the closing date of submission of application through Google Form i.e., **21 August 2026**
2. The period of experience wherever prescribed shall be counted after obtaining the prescribed qualification.
3. The above vacancies are provisional and subject to variation. The Executive Director, AIIMS Bathinda reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India rules/circulars and requirements.
4. The reservation to SC/ST/OBC/EWS/PwBD shall be as per the GoI, Rules.
5. OBC applicants not covered under the Creamy Layer, as per the Standing Instructions of the Government of India as amended from time to time, seeking age-relaxation, reservation, etc. shall invariably submit the requisite Certificate as per format (**Attached**). The vacancies are being advertised in financial year 2025-26. **Therefore, NCL-OBC certificate issued during financial period 2026-27 i.e. issued after 01.04.2026 will be considered valid. Therefore, OBC candidates must ensure that they have valid OBC certificate issued from 01.04.2026 to the closing date of advertisement i.e. 21 August 2026. Further, the OBC caste certificate must be in the format provided by the DoPT vide OM No.36036/2/2013-Estt.(Res) dated 30.05.2014. Certificate must be valid for employment in Central Government Institution. OBC candidate's eligibility will be based on castes borne in the Central List of Govt. of India.** The OBC certificate should clearly show that the applicant does not belong to the Creamy Layer. Further, for OBC candidates, in addition to the submission of category certificate, a declaration in the prescribed format attached has to be furnished by the candidates during document verification, that he/she does not belong to the creamy layer. In case of not complying with these stipulations, the claim of OBC for reserved status (OBC) will not be entertained. They will, however, be treated as UR candidates (if UR post is advertised). Candidates may also note in respect of the above that their candidature will remain provisional till the veracity of the concerned document is verified by the Appointing Authority.
6. The vacancies advertised under EWS Category are as per the instructions issued by DoPT, Ministry of Personnel, Public Grievances & Pension, Govt. of India, vide OM. No. 36039/1/2019-Estt (Res), dated 31.01.2019. Application under EWS category will be considered subject to submission of Income and Assets certificate on a prescribed format issued by the competent authority and subject to verification of genuineness of the certificate by the issuing authority. In pursuance to DoP&T OM No. 36039/1/2019-Estt (Res), dated 31.01.2019, a **EWS certificate issued in prescribed format for employment in Central Government on the basis of income of financial year 2025-2026 issued from 01.04.2026 to 21 August 2026 valid for the financial year 2026-2027 will be considered valid.**

***Note:** *Language of Certificate should be in Hindi/English Language and in prescribed format for central Government. Candidates who fail to produce valid category certificate OBC/EWS/SC/ST/PWBD etc. during document verification or as and when required to produce the same, the candidature will be cancelled. Any EWS certificate issued beyond above said dates will be treated as invalid.*
7. As per the Govt of India rules, EWS posts will not be carried forward/or considered as backlog vacancy in case unfilled. Hence, other category candidates may be allowed provisionally to apply for such posts subject to condition that they will be considered for such post as an UR Candidate and only if the EWS category post(s) is/are otherwise not filled.
8. Candidates claiming for the reservation in the reserved category (OBC / SC / ST / PwBD etc.), must ensure that they possess a valid category certificate in the **prescribed format of Government of India** attached with this advertisement.

Candidates are advised to visit Institute's website regularly for any updates about this advertisement and selection process.
13. Decision of the Executive Director AIIMS, Bathinda in all matters regarding eligibility/selection would be final and binding on all candidates. No correspondence whatsoever would be entertained by the AIIMS, Bathinda in this regard.
14. In case any information given or declaration by the candidate is found to be false or the candidate has willfully suppressed any material information relevant to his/her appointment, he/she will be liable to be removed from services, and any action may be taken as deemed fit by the appointing authority.

a. SELECTION PROCEDURE:

1. The application of the candidates which will be received within prescribed date and time and who submit the requisite fee will be scrutinized by the scrutiny committee of the Institute and only the eligible candidates will be called for personal interview before the Standing Selection Committee of the Institute. In case, the numbers of applicant are large, the selection committee of the Institute may devise a criteria for short-listing the candidates, which may include holding of written examination.
2. Only the eligible candidates/ shortlisted candidates will be called for interview. However, the same would be provisional subject to fulfillment of all requirements failing which he/she will not be allowed to appear for interview.
3. The information regarding eligibility/ shortlisting of candidates will be published on the website of AIIMS, Bathinda only. The date and time for interview will be intimated to the eligible/shortlisted candidates only and the same will also be published on the AIIMS, Bathinda website (www.aiimsbathinda.edu.in).
4. Interview letters will be sent through email ONLY and the complete interview schedule will also be made

available on website also.

5. The selected candidates will be issued appointment letters. The appointment of selected candidates is subject to his/her being declared medically fit by the competent authority.
6. The decision of the competent authority regarding selection of candidates will be final and no representation will be entertained in this regard.

b. JOINING TIME: -

- *Joining Time will be 30 days from the issue of appointment letter. Extension in joining time will be considered, only in exceptional cases, with the approval of Competent Authority, AIIMS, Bathinda. If one is selected / offered against more than one post, when he/she joins against offered post & opts to change, he/she will not be allowed to change. Candidate who is pursuing any program e.g. M.Ch./DM/Fellowships etc. while applying the post, he/she shall be allowed to join only if he/she has completed the course on or before the last date of joining given in the offer letter. No request to allow to join as faculty and continue to pursue the course will be considered. Any request for extension in joining time to complete such course will summarily rejected.*
