Project Research Scientist-1 (Non-Medical) post will be an essential team member of the Extramural funded multicenter and National clinical research project Titled: ***“Adapting Regional Indian Cuisines Using Mediterranean Principles To Improve Their Anti-Inflammatory Potential- A Multicentric Study (AROMA Study)”*** at AIIMS, Bathinda site.

Responsibilities of the Project Research Scientist-1 shall include implementation of the research protocol for the site i.e., recruiting research subjects, conducting in-depth interviews and qualitative data coding, maintaining follow up records and data entering for the trial purpose. Project Research Scientist-1 shall report to the Principal Investigator at Department of Cardiology, AIIMS, Bathinda, and shall be -

- (1) Coordinating with study coordinating centre (AIIMS, New Delhi) to ensure study related activities performed in accordance with approved study protocol.
- (2) Study documentation and maintenance of study files in accordance with sponsor requirements including, but not limited to, consent forms, case report forms, study specific source documentation etc.
- (3) Manage the day-to-day activities of the study in accordance with the approved protocol including problem solving, communication and protocol management.
- (4) Submission of accurate and timely study related documents such as annual reports, data files, outcomes etc. to coordinating centre (AIIMS, New Delhi) and/or sponsoring agency in accordance with agency policies and procedures.
- (5) Identifying potential participants from clinical records/clinics, explaining the study procedures, and obtaining informed consent. Reviewing eligibility against predefined inclusion and exclusion criteria, documenting screening outcomes, and enrolling eligible participants as per protocol requirements.
- (6) Performing baseline and follow-up assessments including dietary intake evaluation, anthropometric measurements, and behavioral assessments in accordance with standardized study procedures. Recording findings accurately in study forms/databases and ensuring completeness and quality of collected data as per protocol requirements.
- (7) Collecting and recording study-related data in study specific forms and formats, followed by data cleaning and verification. Maintaining organized and secure study files and documentation, and submitting regular updates and reports to the coordinating centre (AIIMS, New Delhi) within defined timelines.
- (8) Scheduling and tracking participant visits, follow-ups, and reminders as per study timelines. Maintaining regular communication, addressing concerns, and implementing retention strategies to minimize dropouts and ensure continued participation.

- (9) Maintaining documentation and records related to study activities and coordinating with the coordinating centre (AIIMS, New Delhi) to ensure adherence to timelines and protocol requirements
- (10) Attending meetings and trainings organized by the coordinating centre (AIIMS, New Delhi) to ensure study related quality operations at the site.
- (11) Reporting and documenting any SAEs occurring during the study as per the sponsor's requirement and coordinating the same with the coordinating centre (AIIMS, New Delhi).
- (12) Obtaining a written consent form of each Participant or from their legally acceptable representative participating in the Study as specified in the Protocol and as required by the Applicable Laws prior to enrolling a Participant into the Study and shall further ensure that all Participants or their legally acceptable representative understand the latest information sheet and consent form approved by the Institutional review board.
