1. Reference to Advertisement Notice No. **AIIMS/BTI/RC/Deputation/2259** dated **05 March 2026**, Addendum No. **AIIMS/BTI/RC/Deputation/2282** dated **02 April 2026**, and Last Date Extension Notice No. **AIIMS/BTI/RC/Deputation/2320** dated **07 May 2026**.
2. With reference to the above-cited advertisement, applications along with the relevant supporting documents received on or before the last date for submission of applications for various posts on Deputation Basis, i.e. **22 May 2026**, have been considered. Based on the recommendations/remarks of the Committee constituted for the purpose, the list of **Eligible**, **Provisionally Eligible** and **Ineligible** Candidates is enclosed as **Annexure-X**.
3. Further, any Ineligible or Provisionally Eligible Candidate who has any objection or representation regarding his/her eligibility may appear on the date of the interview along with relevant supporting documents substantiating his/her claim and present the same before the Document Verification Committee/Selection Committee for consideration of his/her eligibility to appear in the interview.
4. On the day of Interview, provisionally Eligible Candidates shall be permitted to appear in the interview only upon submission of the documents mentioned against their names in the Remarks column, as applicable.
5. Candidates are required to bring the **original certificates/documents** in support of their **Date of Birth (Matriculation Certificate)**, **educational qualifications**, **experience**, **NOC**, **Vigilance and Integrity Certificate**, etc. Failure to produce the requisite original documents may result in the candidate being not permitted to appear in the interview.
6. Candidates whose employers do not follow Central Government Pay Scales are required to submit a comparative chart regarding the pay scale granted to the Official vis-à-vis the corresponding Central Government pay scale, duly certified by their Head of Office, on the day of Interview.
7. Candidates are required to email a **PowerPoint Presentation (PPT)** comprising a maximum of 05 to 07 slides highlighting their bio-data, eligibility, relevant experience, research work (if any), outstanding achievements, etc. The PPT may be sent to recruitment@aiimsbathinda.in with the subject line "**Deputation Post Recruitment – [Post Applied For]**" on or before **24 September 2026**. The name of the candidate and the post applied for should be clearly mentioned in the PPT file name.

8. No TA/DA or accommodation shall be provided to the candidates for attending the interview. Candidates are, therefore, advised to make their own arrangements and plan their journey accordingly. The interview process may extend to the following day, if required.
9. Candidates have been called for the interview provisionally, subject to fulfilment of all the prescribed eligibility conditions, including age, educational qualifications, experience, and other applicable requirements, as per the Recruitment Rules for the respective posts. The eligibility of the candidates shall remain provisional at all stages and shall be subject to verification of the prescribed eligibility criteria. If, at any stage, a candidate is found not to fulfil the prescribed eligibility criteria, his/her candidature shall be liable to cancellation.
