Subject: Late Fee for Delayed Submission of Examination Forms

Based on e-file No. M/466/2025-Dean_Exams dated 20 August 2025 duly approved by the Competent Authority on dated 28 August 2025, the protocol/policy regarding fee for re-totalling of marks and the time limit for submission of applications is as under :

Late Fee Structure:


A late fee shall be charged for delayed submission of examination forms as per the following structure:

- Rs. 200/- for applications submitted within the first three days after the deadline.
- Rs. 500/- for applications submitted during the next three days (i.e., 4th to 6th day after the deadline).
- Rs. 1000/- for applications submitted beyond one week after the deadline, which shall require specific approval of the Dean (Academics).

Implementation:

This order shall come into effect immediately and shall be applicable to all students submitting examination forms henceforth. All concerned departments/offices are directed to take note of and implement this decision accordingly.
