TERMS AND CONDITIONS FOR PROCUREMENT OF HSD

- 1. The quantity required is 20000 Litres (Twenty Thousand Litres only).
- 2. The Fuel required is High Speed Diesel Specifications of the HSD fuel required are attached with this bid document as per Annexure 1.
- 3. The bidder has to supply fuel to the HSD yard located at AIIMS Bathinda through his/ her own vehicle in one go or in phases. Minimum quantity in each phase should be 5000 litres.
- 4. The responsibility for safe and secure transmission from the source of fuel to the HSD yard of AIIMS Bathinda is of the bidder only. Also, unloading of HSD at HSD Yard of AIIMS Bathinda is also in the scope of the bidder only. The tools and tackles required for unloading has to be brought along by the bidder only. After unloading proper packing of the HSD Tanks of AIIMS Bathinda has to be done by the bidder only.
- 5. Payment Terms:- The payment shall be remitted to the successful bidder after receipt of HSD Fuel at yard and on submission of Invoice for the quantity. The quantity delivered at the HSD yard will be inspected by the AIIMS Bathinda officials and only after the satisfactorily report, the bidder will be given an acknowledgement of the receipt of HSD Fuel.
- 6. **Delivery Terms:** The fuel has to be delivered within 20 days after placement of Work Order to the successful bidder. Any delay after 20 days may lead to cancellation of the Work Order issued by AIIMS Bathinda without any compensation to the bidder. AIIMS Bathinda reserves the right to procure the HSD from the next successful bidder also if there is any default by the L1 bidder in following the terms and conditions of the tender document.
- 7. The successful bidder shall warrant and be deemed to have warranted that all stores supplied against this Contract are free and clean of infringement of any Patent, Copyright or Trademark, and shall at all times indemnify the purchaser against all claims which may be made in respect of the stores for infringement of any right protected by Patent Registration of design or Trade mark and shall take all risk of accidents or damage which may cause a failure of the supply from whatever cause arising and the entire responsibility for sufficiency of all means used by him for the fulfilment of the contact.
- 8. Bidder's bill will be passed for payment only after the stores have been received, inspected and accepted by the Purchaser.
- 9. Rejected stores will remain at destination at the Bidder's risk and responsibility.
- 10. The fuel supplied will be inspected by AIIMS Bathinda at the HSD yard. If the fuel is not as per the specifications, then it is liable to be rejected. - the fuel supplied shall be responsibility of the bidder only and appropriate certificates will be submitted to AIIMS Bathinda.
- 11. Single bidder will submit single bid on CPP Portal. Consortium of bidders submitted single bid on the portal is not allowed.
- 12. The make of the HSD Fuel shall be IOCL, HPCL, BPCL or any other authorized retail outlet as authorized by the Ministry of Petroleum & Natural Gas, Govt. of India or its authorized agency. The bidder shall have the appropriate licence to sell the HSD fuel issued by the concerned agency of Government of India and the same shall be uploaded on the CPP Portal at appropriate place.

OTHER TERMS AND CONDITIONS

- 1. Important Information: The Bid document can be downloaded from the CPP Portal. The downloaded document shall be treated as valid document for participation in the bid. However, the cost of the bid document i.e., Rs.1180.00/-in the form of DD drawn in favor of "Executive Director, AllMS Bathinda" payable at Bathinda, Punjab has to be submitted offline and scanned copy of DD to be uploaded online. If tampering of any clause of the bid document is found in the submitted bid document, it will be summarily rejected and EMD amount shall be forfeited.
- 2. Submission of Bids: The bid along with the necessary documents should be uploaded in the CPP Portal as per guidelines mentioned in the portal. Bid has to be submitted only online at CPP Portal in two bid systems i.e. (i) Qualification bid and (ii) Financial bid in the prescribed proforma. 8. The PSD shall be refunded after one month after the delivery of the HSD at AIIMS Bathinda HSD yard and on the satisfactorily inspection of the HSD supplied.

11. The EMD may be forfeited: -

Qualification/Technical Bid:

The qualification bid should be uploaded along with scanned copy of Account Payee Demand Drafts for EMD for Rs. 35,308/- (Rupees Thirty-Five Thousand Three Hundred Eight only) and Rs.1180/- (Bid document cost) along with the requisite documents. 15. Evaluation

- i. If there is discrepancy between words and figures, the amount in words shall prevail prior to detailed evaluation; AIIMS, Bathinda, Punjab shall determine the substantial responsiveness of each bid. A substantially responsive bid is one, which conforms to all the terms and conditions of bid document without any deviation.
- ii. AIIMS, Bathinda, Punjab shall evaluate in detail and compare the substantially responsive bids and comparison of bids shall be on the price/rate of the services offered as indicated in the rate schedulein financial bid of the bid document.
- 16. **Selection criteria to be adopted for evaluation of the bids: -** Selection will be based on the lowest quote received for supply of HSD Fuel at AIIMS Bathinda including all taxes.

17. Annulment of Award

Failure of the successful bidder to comply with the requirement of any of the bid clause shall constitute sufficient ground for the annulment of the award and forfeiture of the EMD. In such a case, the Department may make the award to any other bidder at its discretion or call for New Bid/Tender.

18. Period of validity of bids

The bid shall remain valid as per the terms mentioned on the CPP Portal. A bid valid for a shorter period shall be rejected by AIIMS, Bathinda, Punjab as non-responsive.

19. Dispute Resolution: -

- (a) In case of any dispute, the same will be settled amicably between the parties.
- (b) If the matter is not settled amicably, the same will be resolved through arbitration. The parties shall be bound by the Arbitration and Conciliation Act, 1996 along with all the amendments subsequent thereto.
- (c) Dispute(s) is/are subject to the jurisdiction of Courts of Law based at Bathinda, Punjab, India.

20. Counter Offer to Bidder

The Department reserves right to counter offer the price against price quoted by the bidder.
