AIIMS, Bathinda Blood Bank plans to provide surplus plasma to Indian plasma fractionators as per an initiative approved by the National Blood Transfusion Council.

Sealed Quotations are hereby invited by the undersigned on behalf of the Director, AIIMS Bathinda, for the Institute as per the terms & conditions mentioned below. The filled Quotations, along with all required documents, must reach in the office of the undersigned on or before, The Envelope containing would please be sealed and superscribed as under:-

"QUOTATION FOR SALE OF SURPLUS PLASMA AGAINST INQUIRY

Eligibility Criteria

- The plasma fractionator must be licensed by the Government of India for plasma fractionation to manufacture clinically usable products in a GMP facility.
- The fractionator will remain accountable for updating AIIMS Bathinda about the nature and quantity of all the products manufactured from the plasma received from the institute.
- The fractionator must ensure that none of the products recovered from this plasma will be exported before fulfilling domestic demand.
- A buy-back policy for plasma-derived products from the fractionator will be finalised at the discretion of the Institute.

Terms & Conditions:

1. The quotations received after this deadline & unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay, this institute will not be responsible.

2. <u>Earnest Money Deposit-</u>

The tenderer must pay an Earnest Money Deposit of Rs.40,000/- The same will be refunded without any interest to the successful tenderer only after satisfactory execution of the contract and fulfilment of all contractual obligations. An Earnest deposit must accompany each tender for an amount specified in the tender set. In case of unsuccessful tenderer(s), the Earnest money deposit will be refunded as early as possible.

- Quotations must be in the enclosed prescribed form on the letterhead of the firm duly signed by the Proprietor/ Partner/ Director or their authorised representative; in case of signing of quotation by the authorised representative, the letter of authorisation must be attached with the quotation.
- 4. Rates must be quoted as per the format specified. Taxes extra, if any, must be written separately.
- 5. No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
- 6. The rates quoted must be valid for 180 days, minimum, from the date of opening the quotations, and the silence of any tendered on this issue shall be treated as agreed upon in this condition.

- 7. The technically qualified Bidder who submits the highest financial bid amount shall be declared as a Successful Bidder (H1), and communication to that effect shall be made subject to approval and as decided by the Competent Authority.

- 8. RTGS/NEFT details need to be furnished by the supplier with the quotation on the letterhead of the supplier/firm/agency.
- 9. The firm/agency may satisfy the following conditions and attach a self-attested copy of the same with the quotation:
 - a. Firm shall be registered with the Government of Rajasthan / Central Government.
 - b. The firm shall have valid VAT/ Sales Tax No. and IT PAN.
 - c. The firms should not be blacklisted by any Govt. Agency/Dept.
- 10. Quotations qualified by such vague and indefinite expressions such as "subject to prior confirmation", "subject to immediate acceptance", etc., will be treated as vague offers and rejected accordingly. Any conditional quotation shall be rejected summarily.
- 11. **Delivery Period** 15 days from award of work.
- 12. **Liquidated Damage**:- If the firm fails to lift the material within the stipulated delivery period, then a penalty at the rate of 0.5% per week of the total order value shall be levied, subject to a maximum of 10% of the total order value.
- 13. **Payment Terms**: Payment must be made for the full order before lifting plasma from AIIMS, Bathinda.
- 14. **Disputes:** In the event of any dispute or disagreement arising between the Supplier and any other department of AIIMS Bathinda with regards to the interpretation of "Terms & Conditions" of this inquiry, the same shall be referred to the Director, AIIMS Bathinda whose decision will be final and binding upon the Supplier.
- 15. AIIMS, Bathinda reserves the right to increase or decrease the quantity and/or amount of work. Decision of Quantity of material in the AIIMS, Bathinda will be final in this regard.
- 16. AIIMS, Bathinda reserves the right to reject any quotation, part, or whole of the inviting quotation process without assigning any reason. The decision of the AIIMS, Bathinda, will be final in this regard.
