Following terms and conditions supersede all existing "Buyer added Bid Specific Terms and conditions" given in the bid document or any previous corrigendum. Prospective bidders are advised to bid as per following Terms and Conditions:

Buyer Added Bid Specific Additional Terms and Conditions

- 1. Experience Certificate for the supply of the same to any Govt/ PSU/ any renowned private organisation along with Supply/ Purchase Order.
- 2. If the agency is registered under MSME or NSIC, then EMD exemption certificate needs to be enclosed.
- 3. OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration
- 4. Buyer Added text based ATC clauses

1. The eligibility criteria and selection criteria as per the uploaded ATC shall be followed.

2. The bidders have to upload all the relevant documents required for QCBS criteria.

3. in view of the representations received and to promote more participation the following clauses have b een amended/added:

(i) For: Annual Turnover of the firm should not be less than 02 Crore for the last six financial years.

Read: Annual Turnover of the firm Should not be less than 02 crore for **any** of the last six financial years

(ii) For: Experience of deploying female security staff at least in any one institute/organisation in the last t hree years

Read: Deleted

(iii) For: Past Performance (As per Performa enclosed and signed by an authorised signatory of the instituti on of not less than Gazetted Officer) a) At least from two clients served in the last three years. b) At least one from the existing/active client.

Read: Past Performance (As per Performa enclosed and signed by an authorised signatory of the institutio n of not less than Gazetted Officer)a) At least from two clients served in the last three years **OR** b) At least t one from the existing/active client.

(iv) EMD exemption will be given as per the rules.

(v) A list of previous contracts along with start and end dates to be provided for past performance

(vi) For the calculation purpose and to calculate Lumsump amount that to be quoted on GeM portal, the fo llowing strength will be considered:

a) Security Guards without arms- 350

b) Security Guards with arms- 02

c) Security/Fire Supervisor-18

(vii) 02 Gunmen (with valid arms license) and 05 Security cum fire guards are included in the 370 (tentati

ve) requirements.

(viii) All expenses of QRT Jeep will borne by the service provider. The jeep may run for 400-500 km tentati vely in a month.

(ix) The bikes required as per the tender document should be with valid registration for the next 10 years. All expenses of the bike will borne by the service provider. Each bike may run for 300-400km tentatively i n a month.

(x) The copy of contract/agreement/performance certificate(issued by the client on their letter-head) indic ating details of services provided (ed) to the client to be submitted as evidence/proof of providing service s like RF-AI based security, etc, as per QCBS criteria.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
