# Terms & Conditions for AMC contract

1. No increase in rates shall be considered at all during the entire period of AMC once the contract has been finalized. No other charges like transportation, fare etc for providing the services will be payable by the AIIMS, Bathinda.

2. The service provider shall be contactable at all times as well as messages sent by mobile / email / fax / or any other mode of message from AIIMS Bathinda to the service provider shall

be acknowledged immediately.

3. Payment Terms: - For payment purpose, the bills should be submitted quarterly along with the work completion report / user certificate duly signed by official of the offices concerned with stamp and date.

No advance payment will be made and GST will be paid as per the Government of

India instructions issued from time to time in this regard.

4. As most of the items of work will be of urgent and time bound nature, the work will have to be completed within the stipulated time frame (decided accordingly by AIIMS Bathinda). The firm will have to attend all complaints on priority made by AIIMS Bathinda or any other authorized personal of AllMS Bathinda.

5. The specialized tools and plants for carrying out the work shall have to be arranged by the firm at his own cost and no tools will be arranged by AIIMS Bathinda. The firm shall keep all

required tools at site.

6. During this period the firm will be liable minimum 04 times per year (quarterly) overhauling /

servicing of Equipment during the period of contract.

- 7. The contractor must ensure warranty provided by him for the supplied material is 12 months from the date of its installation. If any material supplied by the firm is found defective / Manufacturing defect during this period, such defects would have to be rectified by the firm for free of cost.
- 8. All complaints have to be attended free of cost including breakdown maintenance within a specific period / time / hour depending upon the urgency of the same. Spare parts not covered under AMC shall be provided by the firm as per actual cost of OEM. The service report shall be submitted immediately with details of fault attended, action taken and further suggestions, if any. The OEM/contractor must ensure CERTIFICATE OF PRICE JUSTIFICATION (Annexure-1) provided by him for the supplied material every time.

9. Any part taken out for repairing or changing or for any other purpose must be authorized by engineer in charge by valid gate pass.

10. During the repairment of that part of equipment, firm must ensure an OEM alternative part must be installed during the time of repairment.

11. The firm should depute only qualified / experienced technicians for carrying out the maintenance work.

12. The firm shall take all precaution for safety of the workmen. If any accident / mishap occurs, the department shall not be responsible for the same. Consequently, any compensation payable shall be at the firm cost.

13. Penalty @ Rs. 500/- per day shall be deducted from the payment if complaints are not being attended within the given period of time i.e., 12 hrs from the time of lodging the intimation / complaint. After carrying out the repair, the service personnel shall submit the service report.
